

In an effort to continue providing our patients with proper oral health, while also taking into account the concerns that COVID-19 bring up, below is a guide to determine **“Essential, Non-Essential, and Emergency”** dental procedures in a time of a national emergency. This is meant to be a GUIDE, and a dentist’s judgement of the situation, based on the patient’s presentation and risk factors, should be the way to make the ultimate decision.

“Essential” treatments are those which should be treated in order to prevent a dental emergency at a later period of time. By providing essential treatments, the intention is to prevent situations where dental patients are visiting our hospital’s ERs and preventing our doctors from focusing on the current COVID situation.

“Emergency” treatments are those that are addressing trauma, severe pain, swelling, and infection. These are patients that if they are not able to be seen by a dentist in a timely manner, will ultimately end up seeking treatment in our emergency rooms. They should be able to contact their dentist, and be seen in a timely manner (if they do not show symptoms of the COVID-19 virus).

Note: Patients age 65 and older should be treated at a time when there are no other patients in the office, in order to follow “social distancing” protocols.
